# III. EXECUTIVE DIRECTOR'S REPORT

Executive Director's Report was delivered by Larry Kay

- A. Budget Update –The House Budget Committee added the \$2 million fund switch from Home Fund to GR in HB 8, however the Senate Budget Committee switched the \$2 million back. After much discussion, Commissioner Callahan made a motion to take an official position to support HB 8 House Budget version. Commissioners Fairfax seconded the motion. By a voice vote the motion passed unanimously. The Commission continues contact with OA-BAP on budget situation. Veterans may also wish to contact their elected officials regarding this issue.
- B. Strategic Direction 2012 focus:

1. Promote a Veteran centered culture within the Missouri Veterans Commission

2. Develop and implement mechanisms with our service partners to communicate, coordinate, cooperate and collaborate (C4)

3. Expand our Veteran Outreach Horizon Commissioner Callahan made a motion to approve the Strategic Direction 2012 as presented. Commissioner Englund seconded the motion. By a voice vote the motion passed unanimously.

# V. STAFF REPORTS

Julie Miller gave overview on completion of Statewide Audit:

1. Comprehensive Annual Financial Report (CAFR) – This was a statewide financial statement audit. The Home Fund was audited as part of this audit. No MVC findings were reported.

2. Single Audit – This was a statewide audit of federal programs. The federal VA per diem and construction grants were included in this audit. The VA per diem was the only major program for MVC, so it was the only MVC federal program audited. No current year findings for MVC were reported in this audit. The report includes a follow up to an FY2009 finding, which has been corrected.

### VIII. NEW BUSINESS

A. U.S. Department of Veterans Affairs- David Unterwagner, Director St. Louis VA Regional Office reported on the Veterans Benefits Taskforce. He explained fully developed claims and identified other issues that slow claims processing and ways to resolve.

Mr. Unterwagner also gave a brief overview of the VA-IDES Program. The Integrated Disability Evaluation System provides a seamless and transparent disability evaluation process that is administered jointly by the departments of Defense and Veterans Affairs. Service members complete both the military and Veterans Affairs processes in an average of nine and a half months while receiving military pay and benefits. They require just one set of physical examinations instead of two, receive disability ratings that are accepted by both departments, and leave the service with completed Veterans Affairs disability benefit claims in place. The St. Louis VA Regional Office will target active duty service members at Ft. Leonard Wood and Whiteman Air Force Base starting July 2011.

- B. Missouri Association of Veterans Organizations (MAVO) Jessie Jones, Chairman advised the Commissioners of MAVO's concerns with MVC budget and legislation they are actively pursuing.
- C. U.S. Department of Veterans Affairs Sallie Houser-Hanfelder, Director, Harry S Truman Memorial Veterans Hospital gave a brief update on current activities at the VA Medical Center.
