II. APPROVAL OF MINUTES

A. Commission Meeting Minutes January 30, 2017

Member Wooten made a motion to approve meeting minutes as written and Member Mowrer seconded the motion. By a voice vote the minutes were passed unanimously as written.

III. EXECUTIVE DIRECTOR'S REPORT

The Executive Director's Report was delivered by Larry Kay, Executive Director.

A. FY 2018 Budget –

1. Director Kay thanked the Commission's Elected

Officials for their help and leadership in this years budget process

- 2. \$750,000 loss in General Revenue
- 3. Representative Davis sponsored amendment for a fund switch to the Home Fund
- 4. Received inflationary increases in the Home Fund for FY2018

FY2019 Budget Challenges:

- 1. Veterans Full Cost of Care
- 2. Pharmacy
- 3. VSO Salary Increases
- 4. RN & LPN staff shortages

Recommendations will be distributed at August Commission Meeting

- B. Meeting with the Federal Department of Veteran Affairs Chairman Englund and Tim Norton, Facilities Operations met with the VA on March 21, 2017.
 - 1. The VA will only support 1,257 authorized beds although we are grandfathered for our current 1,350 beds.
 - VA will participate in the replacement of the 150 bed Mexico Veterans Home. VA's portion of this total would be approximately 60% federal and 40% state
 - 3. VA indicated they would not participate in adding any additional skilled nursing beds in Missouri.
 - 4. VA indicated Adult Day Care is a national priority since the cost is lower and it allows Veterans to stay at home as long as possible
 - 5. No construction grants or per diem will be available for Assisted Living Facilities
 - VA is looking at states being able to have contract agreements for placing Veteran in private nursing homes

A. VSO Salary Increases –The Commission is still working with our elected officials, Human Resources and OA in changing classifications and pay range.

A. Executive Order 17-03 Regulations – Director Kay advised that the Commission did a comprehensive review of all MVC regulations in 2015 and determined that the existing regulations are basically a brief description of the organization and how each program is structured. There are no unnecessary costs created by the regulations nor do they create any adverse effects. Director Kay recommended the adoption of Governor Executive Order 17-03 and our report as written. Member Wooten made a motion to accept Executive Order 17-03 and our report as written. Member Mowrer seconded the motion. By a voice vote the Executive Order 17-03 was passed unanimously as written.

- B. Executive Order 17-09 Parental Leave Director Kay advised the Missouri Veterans Commission has complied effective March 13th. He advised he is bringing this decision to comply with Executive Order 17-09 back to the Commissioners for final review and consideration. By a voice vote the Executive Order 17-09 was passed unanimously as written.
