A. VSO Salary Increases – A directive was given July 2015 from the Commissioners, requesting \$600,000 for increase for VSO's salaries, \$200,000 was approved effective July 1, 2016. The Commission has submitted to the Department of Public Safety and the Office of Administration (OA) an additional increase of \$400,000 for FY2018. Included in this amount is \$18,000 for Program Secretarial Support. The Commission is scheduled to meet with OA and the Governor's Transition Team in November. The Commission is still working with Human Resources and OA in changing classifications and pay range.
