- A. Salary Adjustment Proposals Director Kay
 - Homes Program Recommend using existing funding for equity increases for 25 positions in the Homes not to exceed \$68,000. After much discussion member Wooten made a motion to provide equity increases for 25 affected positions in the Homes Program for a sum not to exceed \$68,000. Effective this next full pay period. Member Mowrer seconded the motion. By a voice vote the motion passed unanimously.
 - 2. Veteran Service Program Ask for direction from the Commission to put in the budget this year pay increases for Veteran Service Officers, Claims Representatives and Supervisors not to exceed \$600,000 for FY 2017. After much discussion member Wooten made a motion that we direct that the Veterans Service Program Personal Service Budget be increased by a sum not to exceed \$600,000 for the FY 2017 budget. Member Boyer seconded the motion. By a voice vote the motion passed unanimously.
- B. United States Department of Veterans Affairs –Robert Ritter, Associate Director Harry S Truman Memorial Veterans' Hospital reported on the following:
 - Access to Care and Waiting List
 – Average Access to
 Care waiting time for "New" Patients" 13 days for
 Mental Health, 13 days for Primary Care, 20 days for
 Specialty Care Patients. Greater than 92% of all

- appointments have been accomplished in 30 days or less.
- Veteran Access, Choice, and Accountability Act (VACAA) – A total of 4,430 Veterans eligible through VACAA. Received 54.45 additional FTE with VACAA funding for FY2015. Eligibility requirements: Live more than 40 mile radius and/or appointment time more than 30 days out.
- 3. Customer Satisfaction Positive survey results. 90% would recommend Truman VA to other Veterans.
- Construction Update Projects underway: Psychiatry Unit renovation, Audiology relocation and a new Dental Clinic. News Projects: Cardiac Catheterization Laboratory and new Specialty Care addition. Working on a lease for relocation of the St. James CBOC.
- Announcements Harry S Truman Memorial Veterans' Hospital rated 4 Star Facility in the nation. Quarterly Town Hall Meeting for Veterans and Family Members will be held on July 29, 2015 at 1:00 PM at the American Legion Post 5, Jefferson City Missouri.
- C. Missouri Association of Veterans Organizations (MAVO) Richard Heigert announced the next MAVO meeting will be held on September 22, 2015 at 1:30 PM at the DAV in Jefferson City, Missouri. Election of Officers: Tom Mundell, Chairman The Executive and Legislative Committees will meet in November to layout the 2016 legislative agenda.
